Below are the nomination instructions for the Award.

INSTRUCTIONS FOR COMPLETION AND SUBMITTAL OF NOMINATION FORM

1. Read and review the nomination form in its entirety before beginning entries.
2. Complete the form in its entirety including signatures and pertinent dates. If information is inaccurate or missing a form may not be properly judged and as a result may affect consideration for the Award.
3. Additional material highlighting nominee's character, such as letters of recognition or other acknowledgments are acceptable to submit with the nomination form.
4. Each member of the Club may submit one nomination for this Award.
5. Submit the nomination form to Kurtis Eisenbath at kurtis.eisenbath@edm-inc.com by **April 22nd, 2022**. Forms received after the deadline will not be considered for the Award.

BASIC CRITERIA

1. Nominee must be:
 - A member in good standing with the Club.
 - Thirty five (35) years of age or younger before January 1 of the year in which the Award is presented.
 - Affiliated with an occupation allied to engineering, architecture, or sciences in accordance with the Club's membership guidelines.
2. Nominee's professional integrity must be beyond question.
3. Nominee should be active in carrying out his/her civic, community, and public responsibilities.
4. Past recipients of the Award are not eligible for nomination.

PROCEDURE

1. An individual is nominated by a member in good standing of the Club.
2. The Young Engineers' Sub-Committee will review each nomination and make a recommendation to the Board of Directors (Board).
3. Upon approval by the Board, the award will be presented at the Club's Annual Dinner.
